



The Executive Committee recently updated the Discretionary Grant Policy and awarded the following Discretionary Grants in 2025:



These grants reflect our ongoing commitment to building a stronger, more vibrant Greater Beloit - through small business support, educational opportunity, and community investment.

The Greater Beloit Economic Development Corporation (GBEDC) has a Discretionary Grant program to support economic development projects that retain/create jobs, stimulate commercial activity, enhance workforce development initiatives, and/or leverage capital investment in the Greater Beloit area. The program consists of discretionary income generated by GBEDC, and requires matching funds from each applicant. Applicants may inquire about grants at any time, but GBEDC reserves the right to announce specific grant application windows based upon funding availability and organizational priorities.



HO-CHUNK GAMING CASINO BELOIT




Ho-Chunk Gaming Beloit, located on a 32-acre property at Willowbrook and Colley Roads in Beloit, Wisconsin, is poised to become one of the region's premier entertainment destinations.

This \$705 million casino project will include over 1,500 slot machines, 40 table games, a 312-room hotel with a rooftop lounge, a variety of dining and beverage options, and a 2,000-seat convention center designed to host conferences and live concerts.

The grand opening is scheduled for September 2026.

GBEDC supported creation of the USS Beloit Legacy Foundation fund.






